Business results of the fourth quarter of 2024

In the fourth quarter of 2024, the company has been recorded revenue from projects implemented throughout the year, at the same time, we have been reduced expenses to improve the efficiency of projects in order to ensure the completion of our production and business plan of 2024.

Revenue of the parent company in the fourth quarter of 2024 reached 98.448 million VND, down 10% compared to fourth quarter of 2023, profit after tax in the fourth quarter of 2024 reached 17.480 million VND, up 16% compared to the fourth quarter of 2023.

Our subsidiary - Smart Technology Investment and Development Joint Stock Company's revenue in the fourth quarter of 2024 reached 5.308 million VND, down 59% compared to the fourth quarter of 2023, profit after tax in the fourth quarter of 2024 reached 2.108 million VND, up 86% compared to the fourth quarter of 2023.

Consolidated revenue in the fourth quarter of 2024 reached 87.039 million VND, down 29% compared to the fourth quarter of 2023, consolidated profit after tax in the fourth quarter of 2024 reached 18.657 million VND, up 13% compared to the fourth quarter of 2023.

Cumulative business results of 2024

In 2024, the Company's business results grew well compared to 2023, the 2024 revenue and profit plan was exceeded. Consolidated business results accumulated to the end of 2024 are as follows:
